2 Credit Hours. This course will focus on the recognition of patients with neurological dysfunctions clinical presentations. The students participate in conducting assessments and interventions with patients with neurological conditions under minimal supervision. Special attention will be given to the issue of neurological exams, lesion localization, and differential diagnosis utilized for the purpose of clinical diagnosis and providing the appropriate intervention. This course is designed to improve clinical decision-making rationale by analyzing the latest, evidence-based concepts and principles for neurological examinations and interventions.

Attendance policy	Students are expected to attend all or more than 90% of clinical sessions. Each student is expected to attend the clinical session that he is assigned to. All absences will be entered electronically into the University site. If absence is more than 10% student will be banned from the course after electronic notification from the university through student e-mail. Patient followup	Each student or group is required to follow up with the patient for at least five treatment sessions. It?s the student?s responsibility to coordinate treatment sessions (time and dates) with the patients.		
Case discussion	Each group will discuss a selected case (not discussed by other groups) in the form of a PowerPoint presentation. The presentation should include a patient you treated for multiple sessions, the required examination, assessment and evaluation, diagnosis, plan of treatment, and prognosis. Additionally, You should include the findings of the reassessment and the actual treatment during each session. You should also highlight the changes in the clinical outcomes (pain, swelling, ROM, strength, and functionality) that took place throughout the program and how you progressed through the rehabilitation program.		
Patient check list	Each group should make a list of the patient conditions you treated during, this will help the instructor to assign new patients based on your list.		

Plagiarism	ALL THE WRITTEN CLINICAL CASE REPORTS SHOULD BE THE STUDENT OWN WORK. THE STUDENT SHOULD HAVE AN ACTIVE ROLE DURING EXAMINATION AND TREATMENT OF THE CASES SUBMITTED. All the case studies submitted must be seen during this course practical training, and other cases seen during other practicum course will not be accepted.
