2 Credit Hours. Students taking this course will have the opportunity to be placed in a facility outside the University. Differential diagnosis of speech disorders. Methods involved in complete diagnostic speech pathology and liaison with medical personnel. The course provides advanced clinical procedures for assessment of speech disorders in adult and pediatric populations; experience in test administration through supervised laboratory & clinical sessions in educational or clinical settings. Students will have flexibility in scheduling and be supervised onsite by the coordinator of the program.
