This course introduces students to the ethical principles of the pharmacy profession, as well as the principles of pharmacy management, pharmaceutical marketing, and methods of communicating with patients and the medical care team, in order to promote ethical decision-making and a deeper understanding of the Code of Ethics. This course also covers Jordan's current legislation governing pharmacy practice and pharmaceutical registration.
